

## MEMORANDUM OF UNDERSTANDING between



## FACULTY OF FINE AND APPLIED ARTS, KHON KAEN UNIVERSITY, THAILAND

## and

## FACULTY OF PLASTIC ART, HO CHI MINH CITY UNIVERSITY OF FINE ARTS, VIETNAM

This MOU is made at Khon Kaen University (KKU) on the date of  $23^{\rm rd}$  October, 2022 by and between Faculty of Fine and Applied Arts, Khon Kaen University (FA-KKU), Thailand and Faculty of Plastic Art, Ho Chi Minh City University of Fine Arts (FPA - HCMUFA), Vietnam

FA-KKU represented by Asst. Prof. Burin Plengdeesakul. Ph.D., Dean of FA-KKU and FPA – HCMUFA represented by Assoc. Prof. Nguyen Van Minh. Ph.D., Rector of HCMUFA agree to enter into a formal collaborative arrangement based on a foundation of trust for the mutual benefit of the two institutions with the purposes and details as follows:

- 1. FA-KKU and FPA-HCMUFA will jointly develop some or all of the following activities, based on their respective academic and educational needs:
  - a. exchange of students, lecturers and non-academic staff;
  - b. organization of joint research programs;
  - c. exchange of research materials, publications and information;
  - d. other activates mutually agreed upon by both institutions.
- 2. The implementation of further activities using the authority of this Memorandum of Understanding shall be separately negotiated and determined by both institutions.
- 3. Further activity to be developed using the authority of this MOU shall be articulated in a form of agreement (MOA or other types of instruments) which shall articulate the scope of the intended activity and outcomes, financial aspects, and specific persons designated to be responsible for the undertaking.
- 4. Financial aspects of this MOU and further undertakings shall be subject to the approval of each party's authorized agents.
- 5. Use of the name or logo of either institution must be approved by the other institution.
- 6. This Memorandum of Understanding can be revised and renewed by mutual written agreement. It is also understood that either institution may terminate the agreement at any time, with prior notice of three (3) months.
- 7. The Memorandum of Understanding will be valid for three (3) years and become effective when the representatives of both institutions have signed and dated the document.

This MOU is not a formal agreement and shall not be legally binding either party. It should be construed as the statement of intent for both parties to establish future legal relationship when terms and conditions are met by both parties.
